However, the final decision as to whether the competitor has stepped out of the competition area rests with the referee. Judgment shall be made based on the majority rule. In the event of a tie, the referee's decision shall prevail. For "missed the scoring area" or "technique was blocked techniques", both Referee and Judge shall use the gestures specified in the Wado-Kai regulations for "missed the scoring area" and "blocked techniques." If the red competitor ducks their head to evade an attack from the opponent and then raises it, resulting in their head striking the blue competitor's chin or face and causing injury, a warning may be issued. Depending on the situation and the competitor's actions, the warning may be given to the red competitor for contact, or to the blue competitor for being defenseless. If a red competitor who has fallen to the ground uses a kick or similar technique to defend themselves, resulting in an injury to the blue competitor, a warning may be given depending on the match situation and the competitors' actions. The warning may be given to the red competitor for contact or to the blue competitor for being defenseless. Protests cannot be made against the referees panel's decisions regarding the competition matters that do not involve rule violations. During the competition, if a rule violation occurs, the Match Supervisor will blow the whistle to notify the Referee (SHUSHIN).
